The appellant Sri Sarat Ch. Malakar and the Public Authority Sri Debendra Barman, Principal SBSKR Higher Secondary School both are present.

Point No. 1 to 3 of the original RTI application dated 28th June 2014 relates to No. of bicycles allotted year-wise to SBSKR Higher Secondary School, Hajo. The Public Authority stated and produced records regarding list of student beneficiaries to whom bicycles were

distributed for the year 2012-13 together with his demand list submitted to the Inspector of Schools. The appellant also agreed that he has received both the lists but expressed doubts whether the number of cycles sanctioned by Inspector of Schools is different from the number of cycles distributed by the Principal of the School. From this and from the submissions made by the Public Authority it appears that he has given the information that is available with him. The appellant may, therefore, approach the Sanctioning Authority, i.e., Inspector of Schools, Kamrup (Rural) for information on the number of bicycles sanction for the year 2012-13 to address his doubts. As for other years also he may obtain the figures from Inspector of Schools and based on that he may file separate RTI petition for the cycles distributed by the Principal of the School, seeking the details of beneficiaries to whom cycles were distributed

Points No. 4,5,6,7,8, 9 and 10 relates to construction of boundary wall of the SBSKR Higher Secondary School, Hajo. The Public Authority who is present stated that he has already given a copy of the Resolution of the SMDC relating to the construction of boundary wall. It was decided to construct a wall by constituting a Construction Committee. The Construction Committee executed the work themselves under their own supervision without engaging any contractor, as stated by the Public Authority. Therefore, the Public Authority stated that the documents mentioned at points No. 5,6,7 & 8 are not available with him and therefore, he could not give the same to the petitioner. His submission on this was accepted.

As regards Point No.-9 relating to relevant pages of cash book showing the expenditure for the boundary as recorded and Point No-10 relating to supporting vouchers in connection with the expenditure incurred for construction of the boundary wall, the Public Authority is directed to furnish to the appellant the relevant information **within 15 days.**

With this order, the appeal petition is disposed of.
