ORDER 16.3.2015

The complainant Shri Hechon Sitlhou is present. The SPIO of the Public authority, namely office of the Chief Executive Officer of Dima Hasao Autonomous Council, Haflong, District Dima Hasao, Assam is absent without any information or without seeking leave of absence from the Commission. In absence of the Public Authority, the complaint petition is taken up for hearing ex-parte.

After perusal of the original RTI petition dated 24.04.2012, it is seen that the applicant/ appellant sought information against four items. Of those four items, item no. 1,3 and 4 relate to the National Highway Authority of India for which the applicant/appellant may approach the Central information commission, New Delhi.

Item No. 2 relates to payment of compensation for land acquisition for which Dima Hasao Autonomous Council is the competent Public Authority.

From perusal of the case records, it is seen that the original RTI application was transferred by this Commission to the Chief Executive Officier, Dima Hasao Autonomous Council vide this office letter dated 27 April, 2012 followed by transfer of the first appeal petition also to the CEO, Dima Hasao Autonomous Council, Haflong vide this office letter dated 13.8.2012.

The appellant submitted that till date he has not received any response from the SPIO as well as the first Appellate Authority of Dima Hasao Autonomous Council Office. Therefore he has approached this Commission with his complaint petition dated 29.11.2012.

Enclosing a copy of the original RTI petition, issue summon to the SPIO in the office of the Principal Secretary, Dima Hasao Autonomous Council, Haflong to appear before this Commission on 23rd April, 2015 at 1.15 PM to make their oral and written submissions and to produce relevant documents belonging to the information sought for by the appellant.

This order is issue U/S 18(3) of the RTI Act, 2005.
