## ORDER 11-2-2015

- 1. The Public Authority, i.e. the Director of Elementary Education, Sri U. C. Das appeared. Dr. A. Gogoi, SPIO and Joint Director, Elementary Education, Assam has sent a written submission regarding her inability to attend due to ankle injury and her being on leave.
- 2. The SPIO made another written statement dated 7<sup>th</sup> February, 2015 narrating the secquence of actions taken by her. From a perusal of records, it appears that in pursuance to this Commission's letter No. SIC/KP(M).668/2011/25 dated 16<sup>th</sup> May, 2012, the then SPIO in the Directorate of Elementary Education directed the District Elementary Education, Dhubri to furnish the required information to the petitioner within 10 days from the receipt of this order. The Commission directs the District Elementary Education officer, Dhubri to show cause as to why he shall not be penalized under Section 20(1) of the RTI Act, 2005 for not appearing in today's hearing without information or any prayer seeking leave of absence, and thereby casuing obstruction in furnishing the information to the petitioner.
- 3. The petitioner/Appellant Sri Salim Ahmed is absent without any information or submitting any prayer seeking leave of absence. However, he appeared while the hearing was going on, He has made a written submission stating that the

only specific information that he wants now is the action taken by the Director, Elementary Education, Assam on the report submitted by Addl. Deputy Commissioner (Development), Dhubri District vide his letter No. DDM.43/2010/65 dated 23-3-2011. The appellant also submitted copy of Addl. Deputy Commissioner (Development)'s report. The Commission has entered the same in the case record and gave a copy to the Director, Elementary Education with the direction that he shall furnish the information about action taken by him on the report of Addl. Deputy Commissioner, Dhubri's report mentioned above, within 15 days and report compliance.

With the above order, the second appeal petition is disposed of.
