**O R D E R  
09-02-2015**

The SPIO of the Directorate of Secondary Education Sri Harendra Nath Sarma and the appellant Sri Anup Hazarika are present.

The SPIO made a written submission vide letter No.AAP/RTI/15/2012/26 dated 7-2-2015 addressed to the Secretary and Registrar, Assam State Information Commission, enclosing a copy of letter No.AAP/RTI/15/2012/19 dated 10<sup>th</sup> July, 2013 addressed to Sri Anup Hazarika, RTI petitioner, along with a list of applications forwarded to APSC. The appellant Sri Hazarika submitted that he has received the communication dated 10<sup>th</sup> July, 2013, but the same was incomplete in respect of Golaghat, Tinsukia, Baksa, Chirang, Dima Hasao, Karbi Anglong, Kokrajhar, Goalpara, Nalbari, Jorhat and Sibsagar districts.

The SPIO in the Directorate of Secondary Education is hereby directed to clarify whether NIL report means that no applications for these districts were forwarded to APSC or whether the Inspector of Schools of those districts forwarded the applications directly to APSC without routing them through the Directorate of Secondary Education. Since the recommendation for appointment are to be made by the APSC, the Directorate of Secondary Education is expected to have the information.

The SPIO in the Directorate of Secondary Education is hereby directed to clarify the correct position and/or furnish the list of applications (with details) forwarded to APSC in respect of Golaghat, Tinsukia, Goalpara, Nalbari, Jorhat, Sibsagar and Morigaon districts **within 28<sup>th</sup> February, 2015.**

For information regarding Baksa, Chirang, Kokrajhar, and Udalguri, the SPIO in the Directorate of Secondary Education, will transfer the RTI application dated 19-11-2012 immediately to the concerned authorities under the 6<sup>th</sup> Schedule.

Similarly he should also transfer the RTI application to the Dima Hasao and Karbi Anglong districts for necessary action.

The appellant/ petitioner further submitted that the SPIO has not furnished any information about the period of experience of the candidates whose applications were forwarded to APSC. The SPIO submitted that these will have to be collected from the concerned branch in the Directorate of Secondary Education.

The SPIO is directed to furnish these information in respect of the districts under the jurisdiction of Directorate of Secondary Education, Assam to the petitioner **within 15 days and report compliance to the Commission.**

**The First Appellate Authority and the Director of Secondary Education will ensure that the above order is complied with.**
