The Public Authority is represented by Shri Enamul Shah Khandakar, Planning & Statistical Officer & SPIO in the office of the Inspector of Schools, Kokrajhar and Shri Amarendra Roy, Head Master of Dimalgaon High School. The applicant is not present. As such the second appeal petition is taken up for hearing ex-parte.

The Inspector of Schools, Kokrajhar sent a written submission dtd. 9.3.2015 narrating the actions taken by him and the same is entered into the case record. The submission of Inspector of Schools includes a letter written by Shri Amarendra Roy, Head Master of Dimalgaon High School on 21<sup>st</sup> October, 2013 to the applicant Shri Debajit Kr. Roy requesting him to deposit an amount of Rs. 60,000.00 ( sixty thousand) only in the bank account of the school being

maintained with State Bank of India, Kokrajhar Branch within 3 ( three ) days with the assurance that if the actual cost is less then the excess deposited amount will be refunded to him. The Head Master further submitted that till date the applicant has not deposited the amount as suggested.

In view of the above, the second appeal petition of the applicant seems to be without any merit, as such it is rejected.

With the above order the second appeal petition is disposed of.
