#### O R D E R 16.3.2015

The Public Authority is represented by Shri Mukta Nath Saikia, Addl. Deputy Commissioner, Kamrup (M) and Shri Gunajit Roy choudhury, Circle Officer, Hajo Revenue Circle. The appellant Shri M.K. Das is absent without any notice or seeking leave from this Commission. He was absent on the date of earlier hearing on 12.2.2015 also.

In the earlier order dated 12.2.2015 passed by this Commission, the appellant was directed to specify what further documents/ materials/information he requires in addition to what has already been furnished by the SPIO of the office of the Deputy Commissioner, Kamrup (R). However, no communication or request has been received so far from the appellant.

The SPIO and ADC, Kamrup (R) made a written submission dated 13.3.2015 stating that additional information were sent to Shri M.K.
