**O R D E R**

Public authority was represented by Shri S.Viswanathan, IAS, Commissioner, Guwahati Municipal Corporation. The appellant/petitioner shri B.P. Bajoria is absent without any information or prayer seeking leave. The case is taken up for hearing ex-parte.

The SPIO, Shri Aroop Pathak, ACS made a written submission dated 9.2.15 stating, inter alia that the petitioner personally came to the office of the GMC and saw the photographs. Subsequently he sent his representative Shri Nirbhay Kr. Singh, who collected the required photographs from the of the GMC on 29.11.13. At annexure X of the submission made above by the SPIO today there is an acknowledgment in support of receipt of the photograph by Shri Nirbhay Kr. Singh on 29.11.2013. SPIO's submission dated 9.2.15 together with the annexures are entered into the case records.

The second appeal petition submitted by Shri B.P. Bajoria is dated 15<sup>th</sup> July, 2013. Since his representative Shri Nirbhay Kr. Singh collected the required photographs at a later date on 29<sup>th</sup> November, 2013 and since there is no further communication received from the appellant, it is presumed that he received the photographs that he wanted. Therefore, there appears to be no further cause of action and the second appeal petition is hereby dropped and finally disposed of.
