The Public authority was represented by Shri U.C. Das, Director, Elementary Education and first Appellate Authority accompanied by Shri K. Deka, Statistical Asstt. And Shri D.K. Bhattacharjee, Junior Asstt. In the office of the Director Elementary Education. SPIO, Dr. A. Gogoi made a written submission seeking leave of absence for her ankle injury. She is granted leave of absence. The petitioner/appellant Shri Shymal Dutta is absent without any information or prayer seeking leave of absence. However, in view of long pendency of this matter, it is taken up for hearing ex-parte.

From the perusal of the case records it appears that the petitioner/appellant has received no response/information from the SPIO or the first Appellate authority in response to his RTI application dated 4.3.13 and his first appeal petition dated 18.4.13. The Commission directs the Director, E.E. and the SPIO of his office to make available a copy of the enquiry report of the then SDO ( Sadar), Karimganj Shri A.N.B Singh in respect of the select list of 111 numbers of stipendary teachers selected by the SDLA Board, Karimganj,

which was reportedly submitted to the Commissioner & Secretary to the Govt. of Assam, Education Department vide DC, Karimganj's letter No. DC.3/2002 dtd 15.3.03. Director, Elementary Education produced a copy of the report of Shri ANB Singh, the then SDO ( Sadar), Karimganj addressed to the Deputy Commissioner, Karimganj, which was forwarded by the then DC, Karimganj on 15<sup>th</sup> March, 2002 vide his letter No. DC.3/2003 to the Commissioner & Secretary to the Govt. of Assam, Education Department. Commission directs that if the petitioner wants an authenticated copy, he can get it from the O/O DC, Karimganj, from where the report originated.
