ORDER 13-3-2015

The Public Authority was represented by Sri Gopal Ch. Bhowmick, District Fishery Development Officer Incharge District Silchar and Subdivisional Fishery Development Officer, Ramkrishna Nagar, accompanied by Sri Rafiqul Haque, SPIO and Extension Officer in the office of the District Fishery Development Officer, Cachar, Silchar. The appellant Sri A. K. Laskar is absent but he has sent a written submission, expressing his inability to appear before the Commission today, due to hospitalization of his son at Hazi Abdul Mazid Memorial Hospital, Hojai. The appellant has also requested the Commission to pass necessary orders for furnishing the required information free of cost under Section 7 (6) of the RTI Act, 2005. In the absence of the appellant, the case is taken up for hearing ex-parte, as requested by him. The first Appellate Authority and Incharge Fishery Development Officer, Cachar, Silchar has also made a written submission dated 11-3-2015. Both the written submissions of the appellant and the Public Authority are entered into the case record.

The appellant has stated that the SPIO in the office of the District Fishery Development Office did not furnish the information "within the stipulated time period". The DFDO Incharge Cachar, Silchar has stated in his written submission dated 11-3-2015 that the appellant's representative had visited the office of the Public Authority, inspected the relevant documents and expressed his satisfaction after going through the same. However, in view of the appellant's prayer dated 11-3-2015, as mentioned above, the Commission gives him one more opportunity to inspect the relevant documents as desired by him on any working day during office hours within **April-10**, **2015**. Since the appellant does not seem to be satisfied with the inspection already made by his representative, who was satisfied, as reported by the Public Authority, the

Commission directs the appellant to inspect the documents **personally** with prior intimation to the Public Authority.

With the above order the appeal petition is disposed of.
