## ORDER 28-01-2015

The appellant Shri A.K. Laskar is present. The Public Authorities were represented by the first Appellate authority, i.e. Director, Elementary Education, Shri U.C. Das, SPIO, Dr. A Gogoi, Joint Director, DEE and Statistical Assistant in the office of the DEE Shri Khagen Deka.

The original RTI petition was filed on 08.10.2013 followed by first appeal petition dated 30.12.2013. Both the SPIO and the first Appellate Authority did not respond to the petitioner/appellant till date. The SPIO and

Joint Director, DEE has brought some information addresed to the petitioner vide their letter No. DEE/RTI/15/2015 dtd. 27.01.2015.

The appellant has been furnished with a copy of the original appointment letter as LDA of Shri A.K. Phukan who is working now as Sr. Assistant in the office of the DEE. The Director, Elementary Education and SPIO i.e. Joint Director, DEE are hereby directed to furnish the following documents to the petitioner/appellant within 15 (fifteen) days:-

## **List of documents**

- 1. Original joining report of Shri A.K. Phukan as LDA.
- 2. Copies of certificates of educational qualification of Shri A.K. Phukan from HSLC onwards.
- 3. Number and subject matter of files contining various proposal that are pending with Shri A.K. Phukan, Sr. Assistant as on 08.10.2013.
- 4. As regards information sought for in item No. XVI of the original RTI petition i.e. copies of SIU Format, the Public Authority stated that the petitioner did not specify the category of services for which information is sought for. In course of hearing the petitioner clarified that he wants the information for Cachar district for Grade III employees i.e. teachers and Grade IV employees for the calander years 2012, 2013 and 2014. The SPIO stated that she will be in a position to furnish the information if available and if not, she will advise the petitioner from when the information will be available. Accordingly, the SPIO is directed to fulfill her assurance within fifteen days.

The commission noted that the SPIO did not apprise the petitioner about the availability or otherwise of the sought for information till date. The Commission desires that the SPIO will be more careful and prompt in future

in dealing with RTI applications. With the above observations the case is disposed of.
