The petitioner Shri Indra Rongphar is present with his assistant Shri Serlongki Bey. The Public Authority is absent without any information. In the absence of the Public Authority the case is taken up for hearing ex-parte.

From perusal of the case records, it is seen that the original RTI petition dated 02.12.2013 was transferred by the Addl. Chief Engineer (Zone IV), Irrigation Department, Karbi Anglong District, Diphu to the concerned Executive Engineers of (a) Executive Engineer, Irrigation, Karbi Anglong Div. (I), Diphu. (b) Executive Engineer, Irrigation, Bokajan Division (I) Sarihajan, Karbi Anglong and (c) Executive Engineer, Irrigation, Diphu Mechanical Division (I), Bokolia, Karbi Anglong. The petitioner complained that he has not received any information from the Executive Engineers. Thereafter he filed his first appeal petition before the Executive engineer, Irrigation, Karbi Anglong Division (IO), but he complained that he has not received any response from the first Appellate Authority i.e. from the SPIOs concerned in his original RTI petition till date.

The Executive Engineers mentioned at (a), (b) & (c) above are directed to furnish the information as sought for by the petitioner vide his original RTI petition dated 02.13.13, viz photocopies of the approved Annual Action Plan (AAP) on Minor Irrigation Sector under State Plan and HADP (Additive Plan) for the financial years 2007-08 to 2013 - 14 and photocopies of the approved Annual Action Plan

(AAP) on earmarked fund under Accelerated Irrigation Benefit Programme (AIBP) as per the approved Annual Plan Allocation of the irrigation Department, KAAC, Diphu for the financial years 2008-09 to 2013-14 within 15 (fifteen) days from the date of receipt of this order. In case there is any cost involved in copying the documents, they will immediately advise the petitioner to deposit the required cost within 3 (three) days from such intimation.

The SPIOs in the offices of the three Executive Engineers mentioned at (a), (b) and (c) above are also directed to show cause as to why penalty U/S 20 (1) of the RTI Act, 2005 shall not be imposed on them for their non-compliance of the relevant section of the RTI Act, 2005. Their written submissions are to reach this Commission on or before 31st March, 2015.
