ORDER 10-03-2015

The Public Authority was represented by Shri Niren Sharma, MVI cum SPIO in the office of the District Transport Officer, Kamrup (R&L). The petitioner Shri Harinarayan Pathak is present.

Heard both the parties. The SPIO submitted that Office of the RTA, Guwahati transferred the original RTI petition dated 18.11.13 to the Disitrict Transport Officer (R&L) for furnishing the information to the petitioner. Vide letter No. DDK/RL/RTI/2014/135 dated 8.1.14, the SPIO of the office of the DTO (R&L) Kamrup (M) furnished partial information to the petitioner in respect of registration number 0444 against three private vehicle series and one commercial vehicle series. The petitioner wants information in respect of all the series during the period from 1.1.2012 to 31.10.2013. The SPIO submitted that the matter has come to his knowledge only now, after receiving the notice from this Commission. He submitted that he will be able to furnish the remaining information to the petitioner as sought for.

The Commission directs the SPIO to furnish the remaining information within 15 (fifteen) days from the date of receipt of this order.

With this order the second appeal petition is disposed of.
