## ORDER 11-03-2015

The appellant Shri Kutubuddin Ahmed is present. The Public Authority is absent without any information. The case is taken up for hearing ex-parte.

The original RTI petition dated 28.1.14 was addressed to the SPIO of Nalbari DRDA. Having received no information as sought for, the applicant filed first appeal petition on 7.3.14 before the PD, DRDA, Nalbari. He received no response from the first Appellate Authority also and filed the second appeal petition on 20.5.14, which is taken up as a complaint petition in the absence of any order by the 1<sup>st</sup> Appellate Authority.

After perusal of the original RTI petition dtd. 28.1.2014, the Commission directs the SPIO of DRDA, Nalbari to furnish the information to the applicant within 15 (fifteen ) days from the date of receipt of this order.

Further, the Commission directs the PD, DRDA, Nalbari and the SPIO in the office of the PD, DRDA, Nalbari to show cause as to why further action shall not be taken against them for their absence without any information or leave of absence in today's hearing in response to this Commission's notice dated 06.02.2015. The SPIO of the office of the Project Director, DRDA, Nalbari is further directed to show cause as to why penalty U/S 20 (1) of the RTI Act, 2005

shall not be imposed on him for his failure to discharge duties under the RTI Act, 2005. Their written submission to reach this Commission on or before 31<sup>st</sup> March, 2015.
