ORDER 11 03 2015

The applicant Shri Anil Kr. Das is present. The Public Authority is represented by Shri S.A. Laskar, Jt. Director, P&RD, Kamrup Assam, accompanied by Shri Bharat Ch. Kalita, Sr. Assistant. Jt. Director, P&RD has made a written submission, which is entered into the case record.

From perusal of the case record it appears that the original RTI petition was submitted by the applicant to the SPIO in the office of the Commissionerate of P&RD on 5.4.2014, followed by the first appeal petition before the Commissioner, P&RD on 21.5.2014. Meanwhile the applicant has been furnished with partial information as available with the Commissionerate of P&RD.

The Jt. Director, Shri S.A. Laskar submitted that for the remaining information, which relates to Nalbari district, they have transferred the original RTI petition to PD, DRDA vide their letters dated 1.4.14 and 29.5.14. PD, DRDA has not reported any action to the Commissioner, Panchayat & Rural Development so far. However, the applicant submitted that as per his information PD, DRDA, Nalbari has transferred the RTI application to the

concerned Blocks and he has received some information from the the BDOs of a few blocks.

Against the above background, the Commission directs PD, DRDA, Nalbari to collect the information from all the Block concerned and furnish the same with the copies of utilisation certificates to the applicant with information to the Commissioner, P&RD within 15 (fifteen) days from the date of receipt of this order.
