The appellant/petitioner Md. A.K. Laskar is present. The SPIO in the office of the Project Director, DRDA, Cachar and as the first Appellate Authority, the PD, DRDA, Cachar are absent. Since there is no order from the first Appellate authority, the second appeal petition is treated as a complaint petition under section 18 of the RTI Act, 2005 and is taken up for hearing ex-parte.

On perusal of the first RTI application dated 5.3.14, it appears that the information sought for by the petitioner should be available in the office of the Project Director, DRDA. The Commission therefore, directs the SPIO in the office of the PD, DRDA, Cachar as well as the first Appellate Authority i.e. PD, DRDA, Cachar himself to make available the relevant records for inspection by the petitioner/complainant himself within 15 (fifteen) days from the date of receipt of this order. The petitioner should also be given copies of the documents that he wants in response to his RTI petition after depositing the cost there of as estimated by the SPIO of the PD, DRDA office.

Under section 18 (3) of the RTI Act, 2005, the Project Director, DRDA, Cachar and the SPIO in his office are hereby directed to show cause as to why further actions under Section 18, 19 and 20 of the RTI Act, 2005 shall not be taken up against them for their failure to perform the responsibilities under the Act. Their written submission should reach this Commission within 15 days from the date of receipt of this order.
