The appellant/petitioner Md. A.K. Laskar is present. For the Public Authority, BDO, Banskandi Development Block, Shri Punya Prasad Deka and Senior Assistant ( Accounts) Shri Samarendra Bhattacharjee are present. The BDO, Shri Punya Prasad Deka made a written submission dated 23.2.2015 before the Commission today narrating the steps he has already taken to furnish the information in response to the original RTI petition dated 08.1.2014.

The petitioner has stated that he filed first appeal petition before the Project Director, DRDA, Cachar. It is seen from the Enclosure- D of the submission made by the BDO, Banskandi that the Project Director, DRDA, Cachar as the first Appellate Authority passed an order dated 7.3.2014. Therefore, the petitioner's contention that the first Appellate Authority did not take any action is not based on facts. The petitioner is hereby warned not to make false submission before the Commission in future.

It is also seen from the submission of the BDO and the enclosures attached therewith that substantial information have already been furnished to the petitioner. The commission directs the petitioner to approach the office of the BDO, Banskandi Development Block within 15 ( fifteen) days from the date of receipt of this order and inspect documents that he wants to see. If he wants any copies, the BDO, Banskandi will inform him of the cost thereof, which the petitioner will deposit to get the copies.

With the above order the second appeal petition is disposed of.
