Petitioner Md. Nur Mahammod Ali is absent without any information or any prayer for leave of absence. The Public Authority was represented by Shri Dhiraj Kumar Medhi, LDA and SPIO in the office of the Jaleswar Development Block. He was accompanied by Md. Rezaul Islam, i/c secretary, Takimari Gaon Panchayat. BDO of Jaleswar Dev. Block could not attend personally but has made two written submissions, both dated 16.2.2015, which are entered into the case record. The BDO has submitted that he heard the first appeal petition on 11.12.14, where RTI applicant as well as the Secretary, Takimari Gaon Panchayat, both were present. Disposing the first appeal petition, the BDO directed the Secretary, Takimari G.P. to furnish the required information to the applicant within five days which he did. Secretary, Takimari G.P. submitted an acknowledgement receipt signed by the appellant/ applicant, Md. Nur Mahammod Ali giving details of

information/document furnished to the appellant/petitioner. The same is entered into the case record.

The BDO, Jaleswar Development Block, who is the first Appellate Authority for the Block Development Office is also directed to appoint an officer under him instead of an LDA as the State Public Information Officer for the Development Block.

In view of the above, there appears to be no further course of action. Therefore, the second appeal petition is disposed of.
