The Public Authority was represented by Sri Sanjib Kr. Das, Joint Secretary, Revenue & Disaster Management Department, Govt. of Assam. The petitioner Sri Hari Narayan Pathak is also present.

In response to the original RTI petition dated 7-10-2013, the SPIO of the Revenue and Disaster Management Department informed the petitioner that he is not required to furnish the replies to the queries in terms of the Central Information Commission's order dated 21-4-2006 in their file No. CIC/AT/A/06/00045 which is available at Sl. 5 of the case records. Thereafter , the petitioner filed an appeal before the 1<sup>st</sup> Appellate Authority , which was disposed by Commissioner & Secretary, Revenue and Disaster Management Department vide his order dated 3<sup>rd</sup> January, 2014, a copy of which is available at Sl. 7 of the case records. The 1<sup>st</sup> Appellate Authority also reiterated the position of the SPIO with reference to the order of the Central Information Commission referred to above.

The wordings and drafting of the original RTI petition is notwithstanding the basic information sought for by the petitioner is the present status of the land of the Guwahati Central Jail located at Fancy Bazar, minutes of any meeting that took any decision to transfer the land to GMDA for construction of car parking and relevant file notings pertaining to any such decision.

The Commission directs the SPIO , Revenue and Disaster Management Deptt. to inform the petitioner if there is no such decision. If there is any such decision, then the SPIO is directed to furnish the information sought for by the petitioner within 15 days from the date of receipt of this order.

With the above order the second appeal petition is disposed of.
