The Public Authority is represented by Sri Sanjib Kr. Das, Joint Secretary and SPIO of the Revenue and Disaster Management Department. The petitioner Shri Hari Narayan Pathak is also present.

Vide his original RTI petition dated 30-9-2013, the petitioner wanted Photo Copies of Govt. Circular/ Notification No. RSS.605/2013/32 dated 2-8-2013 together with enclosures, if any. The SPIO submitted that the above mentioned communication is not a Circular or Notification, but a letter from the Additional Chief Secretary of Revenue and Disaster Management Department. A copy of the same has already been furnished to the petitioner. The petitioner has also acknowledged receipt of the said letter. The said letter had no enclosures.

Secondly, the petitioner wanted file notings and public documents as mentioned in the file notings. The SPIO of the Revenue and Disaster Management Department vide his letter dated 21<sup>st</sup> October, 2013 furnished Note sheet page Nos. 4,5 & 6 of file No.RSS.605/2013 along with copies of letters mentioned above. The petitioner wants the file note-sheets pages prior to page No. 4. To this the SPIO submitted that those pages are not relevant to original RTI petition dated 30-9-2013.

After hearing both the parties, the Commission directs the petitioner to visit the office of the SPIO and Joint Secretary, Revenue & Disaster Management Department Sri Sanjib Kr. Das during office hours on any working day within 15 days from the date of receipt of this order and inspect the page Nos. 1,2 & 3 of the above mentioned file. If they are relevant to his original RTI petition, then copies of note sheets with relevant documents will be furnished to him by the SPIO.

With this order the second appeal petition is disposed of.
