Appellant Hafiz Md. Nachim Ahmed is present. The Public Authority was represented by Shri Sanjib Kr. Phukan, SPIO in the office of the Directorate of Madrassa Education.

The SPIO made a written submission dated 27.1.15 stating that in pursuance of this Commission's order dated 05.3.14, they have already advised the Superintendent of Nilambazar Senior Madrassa to furnish the information sought for by the appellant directly to him vide letter dated 27.11.13. Thereafter, the SPIO has not heard anything from the Superintendent of Nilambazar Sr. Madrassa. The above mentioned letter of the SPIO is not available in the case record, although the SPIO has given a copy showing that the same was received in the office of the commission on 28.1.15. The SPIO submitted another copy of the letter today.

The appellant submitted that he has not received the information sought for from the Superintendent, Nilambazar Senior Madrassa. It was submitted by the SPIO that the said Madrassa was earlier a venture educational institution, which was provincialised with effect from 01.1.2013.

The said Madrassa being now a provincialised educational institution, the first Appellate Authority i.e. Director of Madrassa Education is hereby directed to ensure that the information sought for is furnished to the appellant/petitioner within thirty days from the date of receipt of this order. With the above order, the second appeal petition is disposed of.
