O R D E R 06-02-2015

The appellant Shri Bipin Ch. Thakuria is present. The Public Authority is represented by Shri Rohini Kr. Das, SPIO and ACF in the office of the Divisional Forest Officer, Social Forestry Division, Goalpara.

Public Authority stated that they have already furnished information as sought for. But the petitioner was not satisfied with the information received, as according to him the information furnished was incomplete. He therefore, filed an appeal before the first Appellate Authority, i.e. the Divisional Forest Officer, Goalpara Social Forestry Division. Vide order dated 3.2.14 the first Appellate Authority disposed of the appeal petition by directing the SPIO under him once again to furnish the information sought for by the petitioner on point No. 3 of the RTI petition i.e. copies of inspection reports of all schemes executed by the Goalpara Forestry Division for the year 2012-13. On non-receipt of the information as directed by the first Appellate authority, the petitioner has now filed this complaint petition. After hearing both the parties and perusal of the relevant records, the Commission directs the SPIO in the office of the Goalpara Social Forestry Division to furnish copies of inspection reports of all schemes

implemented by the Division in the year 2012-13 to the petitioner within thirty days from the date of receipt of this order. Where inspection reports are not available and or inspections were not done, the SPIO will inform the petitioner accordingly with the names of such schemes.
