The appellant Shri Bipin Ch. Thakuria is present. The Public Authority is represented by Shri C.R. Bhobora, IFS, Conservator and SPIO in the office of the PCCF & HOFF, Assam.

The appellant submitted that in response to his original RTI petition addressed to the SPIO in the office of the PCCF and HOFF, Assam, he was given information about the norms of CAMPA schemes. But he did not receive copies of inspection reports of the CAMPA schemes for the year 2012-13 as was sought for by him. Thereafter, the petitioner filed the first appeal petition before the first Appellate Authority i.e. PCCF, Assam on 25.12.2013. But the first Appellate Authority has not taken any action to hear the appeal and redress the grievance of the appellant. Hence the second appeal petition.

From perusal of the records produced by the SPIO, Shri C.R. Bhobora, IFS it is seen that the petitioner was given information about the list of schemes with the amounts thereof and the norms for implementation of CAMPA schemes for the relevant period. But there is nothing on record to substantiate that the petitioner was given copies of inspection reports

relating to implementation of the CAMPA schemes for the year 2012-13. The PCCF, Assam and the SPIO in his office is hereby directed to furnish copies of inspection reports of the CAMPA schemes implemented during the year 2012-13 to the petitioner within thirty days from the date of receipt of this order. Where inspection reports do not exist and or where inspections were not done, the appellant/petitioner will be informed accordingly within thirty days from the date of receipt of this order. With the above order the second appeal petition is disposed of.
