The Public Authority was represented by Managing Director, Sri Pabitra Kr. Kalita, Assam Govt. Construction Corporation Ltd.

The appellant Sri Luhit Mohan, Advocate is absent. Besides the Notice dated 12th January, 2015, the appellant was also informed about today's hearing telephonically by the office of the Commission. In his absence, the Second Appeal petition is taken up for hearing ex-parte.

Vide his original RTI petition dated 26-8-2013, the appellant/ petitioner sought information relating to the voluntary retirement of employees of AGCCL for the period from 1-1-2004 till the date of the RTI application.

MD, AGCCL made oral submission that the State Govt. initiated proceedings to close down the AGCCL in 2005. As a part of the closure proceedings all the employees of AGCCL were released from service after they opted for VRS. At present there is only the Managing Director with 4 Contractual Adhoc employees for updating the accounts to complete the legal closure of the Corporation.

Since the material sought for by the appellant will be voluminous, running into hundreds of pages, the MD AGCCL submitted that it will be difficult for him to make copies of the original materials with the help of 4 contractual employees available with him. He submitted that the appellant/ petitioner may come to the office of the AGCCL for inspection of the relevant records/ materials .

Although the appellant is absent, the Commission directs the Managing Director, AGCCL to make available the required materials for inspection and for making copies by the appellant during working hours on working days **within 1 (one) month from the date of receipt of this order.**

In this connection, MD, AGCCL's letter No AGCC/E/04/07-08/47 dated 23rd September, 2013 , inviting the appellant to come for inspection and taking copies of the relevant materials, a copy of which is available in the case records, is noted.
