The appellant Smti Sakila Akhtar Choudhury was represented by Sri Ashab Ali Ahmed, as authorized by the appellant vide her letter dated 29th January, 2015.

The Public Authority did not appear, although Notice was served by Registered post, nor did the Public Authority submit any reply to the Show Cause Notice. Hence the matter is taken up for hearing ex-parte.

Vide her original RTI application dated 10-1-2014 the appellant raised 3 issues as 3 questions. Issue nos 1 & 2 relates to information which fall within the domain of the RTI Act and which the concerned Public Authority is required to furnish under the Act in reply.

Therefore, the concerned SPIO and the First Appellate Authority i.e., the BDO of Kalain Development Block is directed to furnish the required information to the petitioner/ appellant within 15 days with intimation to the Commission.

The Commission also notes that the SPIO and the 1st Appellate Authority did not respond to the RTI application and the 1st Appeal petition of the petitioner/appellant without any reasonable cause. **Therefore, a penalty of Rs. 5000/- is imposed on the SPIO which will be deposited in the Head of Account-“0070-Other Administrative Services” by Treasury Challan and a copy of the Treasury Challan shall be submitted to the Commission by Registered post within 15 days.**

The First Appellate Authority i.e., the BDO, Kalain Development Block is also hereby directed **to be prompt and responsive in future in dealing with RTI applications in his capacity as the First Appellate Authority.**

As regards issue No.-3, the SPIO will apprise the petitioner/ appellant about the present status of the application for IAY Houses by Mrs Rajia Begum Choudhury and Salma Begum Choudhury.

The other part of issue No. 3 is an allegation of corruption which does not come within the ambit of the RTI Act. The appellant may file her complaint before the Competent Vigilance Authority.

With the above order the appeal petition is disposed off.
