The appellant Sri Taizuddin Ahmed is present. The Public Authority is represented by (1) Shri B. K. Bharali, CDPO accompanied by Sri Diganta Das, Statistical Assistant, Barpeta ICDS Project.

The second appeal petition is taken up for hearing in presence of both the parties.

Vide his RTI application dated 24-1-2012, the applicant wanted to have the following information for the years 2007 to 2012 :

1. **Copies of Notifications/ orders constituting the Anganwadi Centres under village-Bagudi Centre No. 3 , No. 7 Bagudi Gaon Panchayat.**
2. **Population as per survey report.**
3. **List of pregnant and women as well as adolescent girls/ small children**
4. **Copy of Cash Book for the years 2007-2012.**

The appellant submitted a copy of a response from the CDPO office dated 14-2-2012 asking him to deposit Rs. 6,336/- for obtaining copies of the documents/ information required by him. The applicant did not deposit the amount since the letter dated 14-2-2012 did not contain any break-up of the cost- as stated by him.

He further submitted that he received the letter dated 14-3-2012 after expiry of 30 days. However, the CDPO Barpeta, ICDS Project made a written submission dated 24-3-2015, enclosing a copy of "Certificate of Posting" showing that the letter dated. 14-2-2012 was posted on 22.2.2012., The Commission accepts this date of dispatch.

The appellant Sri Taizuddin Ahmed mentioned that he is still interested to have the information. To expedite the same the Commission directs the CDPO, Barpeta to allow the applicant Sri Taizuddin Ahmed to inspect the relevant documents within 15 days during office hours on any working day

from 1<sup>st</sup> April, 2015 to 30<sup>th</sup> April, 2015 and allow him to take photocopies or make extracts / copies of the information that he may so desire by paying Rs. 2 per copy for photocopy.

With the above order the appeal petition is disposed of.
