## ORDER 24-3-2015

The Complainant Sri Chand Mahammad Ali Ahmed is present. The Public Authority is absent without any information or without seeking leave of the Commission.

The Complaint petition is taken up for hearing exparte in the absence of the Public Authority, i.e., the SPIO of the office of CDPO, Mandia, Dist-Barpeta.

The original RTI application dated 13-10-2011 was addressed to the CDPO, ICDS Project , Mandia. Having not received any information from the SPIO of CDPO, Mandia's office, the applicant filed an appeal petition before this Commission on 12-12-2011. The Commission forwarded the Complaint petition to the Dist Social Welfare Officer, Barpets. Having not received any response from the DSWO, Barpeta also the applicant filed another appeal petition dated 12-4-2012. The appeal petition dated 12-4-2012 was perused by the then State Information Commissioner Sri M. C. Malakar on 29-102012 and fixed 9-11-2012 for a formal hearing. The case was heard on 9-11-2012 by the then State Information Commissioner, Sri M. C. Malakar and an order was passed directing the CDPO, Mandia, Barpeta to furnish the information to the appellant within 15 days from the date of receipt of the order and also to show cause as to why he will not be penalized under Section 20(1) of the RTI Act.

The Complainant submitted before the Commission today that he has not got the information till date. The Commission's Registry also has not received any written reply to the Show Cause Notice from the CDPO, Mandia , Barpeta till date.

Issue Summons under Section 18(3) of the RTI Act, 2005 through Superintendent of Police, Barpeta,to (i) the District Social Welfare Officer, Barpeta, (ii) SPIO in the office of CDPO, ICDS Project, Mandia and (iii) CDPO,

ICDS project, Mandia to appear before this Commission on <u>24-4-2015</u> at 1.30 <u>P.M</u> with all relevant records pertaining to the RTI petition for giving oral or written evidence,' on Oath'.

Issue Notices for appearance to the Complainant also.
