The petitioner/ appellant Sri Diganta Dev Asomiya is absent without any information or seeking leave of the Commission for his absence.

The Public Authority is represented by Sri Harendra Nath Sarma, SPIO and Deputy Director in the office of Directorate of Secondary Education, Assam. The case is taken up for hearing ex-parte in the absence of the appellant.

The SPIO and Deputy Director submitted that vide their letter No. GB-EST/RTI/15/2013/Pt/22 dated 1<sup>st</sup> March, 2014, he informed the RTI applicant that the information sought for by him will be furnished after receipt of 3<sup>rd</sup> party consent. By sending copies of the same letter he sought the consent of the third parties.. The SPIO further submitted that he has not received the consent from anyone so far. Therefore, he has not been able to furnish any information to the applicant.

The SPIO and Deputy Director also submitted that the number of third parties is quite large. Meanwhile, the SPIO will send a reminder to each member of the third party, asking them to communicate their consent or objection, if any, for disclosure of the information as sought for by the RTI applicant. If no information is received , or if information is received only from some of them, the Commission will thereafter proceed to take a decision on the basis of available facts and materials before it.
