The appellant Sri Hiranya Deka is present. The Public Authority is represented by Sri Nabajyoti Kalita, Asstt. Executive Engineer in the office of PWD, Nalbari Rural Roads Division and (2) Sri Ratul Kr. Das, Junior Engineer in the same office. The case is taken up for hearing in presence of both the parties.

The original RTI application dated 3-10-2013 was addressed to the Executive Engineer, Nalbari PWD Rural Roads Division. Having not received any information, the applicant filed the first appeal petition before the Chief Engineer, PWD (Roads) Division, Guwahati. Having not received any response from the Chief Engineer, PWD (Roads), the appellant has approached this Commission with a second application. The Commission has noted that the applicant should have filed his first appeal petition before the First Appellate Authority, i.e., the Executive Engineer, Nalbari PWD (Rural) Roads Division.

The SPIO and Asstt. Executive Engineer in the office of Executive Engineer, PWD (Rural) Roads Division, Nalbari made a written submission dated 16-2-2013 stating that they have already furnished the information to the applicant by the ordinary post in the address given by the applicant in his RTI application. The appellant Shri H. Deka stated that he has not received the information. The SPIO handed over a copy of the information already sent by him to the applicant/ appellant before the Commission today. Shri H. Deka, the appellant acknowledged receipt of the same.

With the above order, the second appeal petition is disposed of.
