The appellant Shri Satya Narayan Das is present. The Public Authority is represented by Shri Dilip Kr. Deka, office of the Asstt. Executive Engineer, PWD, Tamulpur Rural Road Sub-Division and SPIO in the office of the Executive Engineer and Shri Madhab Deka, Junior Engineer, office of the Asstt. Executive Engineer, PWD RR Sub-Division, Tamulpur. The second appeal petition dated 3.3.14 is taken up for hearing in presence of both the parties.

The Asstt. Executive Engineer, PWD submitted before the Commission a copy of his letter dtd 23.3.15 addressed to Shri Satya Narayan Das, the applicant/appellant giving him the required information. The appellant admitted that he has received the above information but he complained about the delay in receiving the information. Junior Engineer, Shri Madhab Deka explained that the RTI application did not write the correct name of the road in his application. Later the Public Authority has collected correct name of the road after personal contact with the applicant. That is why there was delay in furnishing the information. The name of the road is not “ Motonga – Nagrijuli Road” but “ Tamulpur – Udalguri Road. Accordingly the Public authority has furnished the information.

The applicant's main concern was the poor condition of the road at present. The Asstt. Executive Engineer submitted that major upgradation work of the road is going to be undertaken soon under ADB funded programme. Sanctions have already been given and work order has also been issued.

In view of the above, the second appeal petition is disposed of.
