ORDER 7.4.2015

The complainant Md. Nasher Ali is present. The Public Authority is represented by Shri Ghanashyam Das, Inspector, Food, Civil Supplies & CA, Barpeta and Shri Dimbeswar Barman, Secretary, Pachim Chenga SS. The complaint petition dtd 5.3.2013 is taken up for hearing in presence of both the parties. The Dy. Director, Food, Civil Supplies & CA, Barpeta made a written submission detailing actions taken by him and authorising Shri Ghanashyam Das, Inspector, FCS&CA, Barpeta to represent. His written submission is entered into the case records.

The brief of the case is that Md. Nasher Ali filed his RTI petition to the SPIO in the office of the Dy. Director, Food, Civil Supplies & CA, Barpeta on 21.11.12 seeking information on lifting, transportation and distribution, etc., of AAY and mid day meal rice by the Secretary of Pachim Chenga GPSS during the years 2006 to September, 2012. The above RTI application was transferred by the Deputy Director to the SPIO of Secretary pachim Chenga GPSS on 27.11.12 with direction to furnish the information to the applicant within 30 (thirty) days. On 13.12.12 the Secretary of the Pachim Chenga GPSS informed the applicant by a letter to collect the required information from the GPSS office before 15.12.12 by depositing Rs. 2.00 per copy. The appellant submitted that he went to the GPSS office before 15.12.12 but could not meet the Secretary, GPSS as he was away. Thereafter he filed the first appeal petition

before the Deputy commissioner, Barpeta on 4.1.13 and now the complaint petition before this Commission on 5.3.13.

It appears that the second complaint petition has arisen because of communication gap between the applicant and the Secretary GPSS. The Secretary, GPSS has no objection or problem in handing over the required information. The applicant is also willing to receive the information sought belately. Since the Secretary of the GPSS has brought with him the required information, the Commission directed him to hand over the same to the applicant before the Commission today. Accordigly, the information numbering 22 (twenty two) pages were given and received in presence of the Commission today.

With the above, the complaint petition is disposed of.
