ORDER 24.3.2015

The applicant/appellant Shri Fazar Ali is absent without information or without seeking leave of the Commission. The Public Authority is represented by Shri Ram prasad Saikia, SPIO and APO(T) of Goalpara Zilla parishad. The second appeal petition is taken up for hearing ex-parte in the absence of the appellant.

The SPIO has made a written submission stating that on 11.11.13 the RTI application was sent to the Block Development Officer (BDO), Kharmuza Development Block, Goalpara since the information sought for by the applicant is available in the said Block office. The SPIO sent a reminder to the BDO on 31.12.13. However, the SPIO has not received any response from the BDO and he is not aware whether the information is furnished to the applicant.

The commission directs the SPIO in the office of the BDO, Kharmuza Development Block, dist. Goalpara to furnish the information sought for by the RTI applicant vide his original RTI application dated 6.9.13 directly to the applicant within 15 days from the date of receipt of this order.

The SPIO in the office of the Kharmuza Development Block is further directed to show cause as to why penalty under section 20 of the RTI Act, 2005 shall not be

imposed on him for his failure to furnish the information to the applicant within the stipulated time period. Reply to the show cause notice to reach the Commission within 30 (thirty) days from the date of receipt of this order.
