The RTI applicant Shri June Bora is absent without information or without seeking leave of the Commission for his absence. The Public Authority is represented by Shri Longbir Teron, the SPIO and the Asstt. Registrar, Co-op Societies (ARCS) and by Shri Sarsing Terang, Secretary, Dokmoka "Lamps", Dist. Karbi Anglong, Assam. The case is taken up for hearing ex-parte in the absence of the applicant. The ARCS has made a written submission dtd 19.3.2015 stating that the information sought for by the applicant are not available in their office. The information relate to distribution of PDS items from the Coperative Societies. His written submission is entered into the case records. Secretary, Dokmoka Lamps, Karbi Anglong has also made a written submission dtd 21.3.15, stating that the RTI applications were received by the Chairman of Lamps and did not inform the Secretary of it. The Secretary of Dokmoka Lamps came to know the RTI application only from the ARCS, Diphu. Thereafter he personally met the applicant Shri June Bora and informed him about his inability to furnish the records, which is quite voluminous, within a short period of time. Secretary, Dokmoka Lamps has however, stated in his written submission that he will be in a position to furnish the information to the applicant within April, 2015. In view of the volume of information and documents involved, the secretary, Lamps is granted time upto 30th April, 2015 for furnishing the required information to the applicant. Since

the Secretary, Dokmoka Lamps could not furnish the information within the stipulated period of 30 (thirty) days, he is directed to furnish the information free of cost. The prayer of the ARCS and SPIO, Diphu and Secretary Dokmoka Lamps for condonation of delay is condoned and with the above order the second appeal petition dtd 8.11.12 is disposed of.
