ORDER 27.3.2015

The applicant/ appellant Shri Rajen Dutta is present. The SPIO in the office of the Secretary, Pachim Machkhowa Samabai Samittee (PMSS) is absent without information or without seeking leave of the Commission for his absence. In the absence of the SPIO, the case is taken up for hearing ex-parte.

It is seen from the case record that the original RTI petition dtd 14.5.2013 was addressed to the Secretary, Pachim Machkhowa Samabai Samittee. The information sought for by the applicant related to lifting and distribution of essential commodities by the Samabai Samittee under the PDS. On 17.6.2013 the Secretary of PMSS by a letter informed the applicant to deposit Rs. 1820.00 (Rupees one thousand eight hundred twenty) only in the office of the Food & Civil Supplies Deptt., Dhakuakhana toward the cost of photocopying of the documents. After receipt of the letter dtd 17.6.2013 from the Samabai Samittee, the applicant filed first appeal petition before the Asstt. Registrar of Co-operative Societies on 01.7.2013. The appellant's main contention was that break-up of Rs. 1820.00 was not given to him. The Commission directs the Secretary of PMSS Ltd to furnish the required information to the applicant free of charge upto 50 (fifty) photocopies and at a cost of Rs. 2.00 (Rupees two) per photocopy thereafter within 15 (fifteen) days from the date of receipt of this order.

With the above order, the second appeal petition is disposed of.
