ORDER 23.3.2015

The petitioner Shri Vinod Mandal is present. The Public Authority is represented by Shri Dhaneswar Roy, D.I. of Schools, Goalpara and Md. Jehirul Islam, Sr. Asstt. in the office of the DI of Schools, Goalpara. The case is taken up for hearing in presence of both the parties.

The original RTI application dated 8.5.14 was addressed to the SPIO in the office of the Deputy commissioner, Goalpara. Deputy Commissioner, Goalpara's office vide letter dated 15th May, 2014, the RTI application was transferred to the Block Elementary Education Officer, Matia by the Addl. Deputy Commissioner and SPIO in the DC's office, Goalpara. The RTI petition was further transferred on 03.6.2014 by Block Elementary Education Officer, Goalpara to the DI of Schools, Matia.

It is seen from the case records that vide letter No. 12543 dtd 27.6.14, the DI of Schools, Goalpara furnished pointwise information to the RTI applicant Shri Vinod Mandal.

Not satisfied with the information furnished by the DI of Schools, goalpara and alleging that he was misguided by the DI of Schools, Goalpara.

The DI of Schools, Goalpara, Shri Dhaneswar Roy was present and submitted that the incident of burning of the school took place in 2013 and Shri Roy joined some time in May, 2014. So he had to depend on his staff to provide the required information, which he did vide his letter dated 27.6.14. On receipt of the notice from this Commission he re-examined the information furnished by him and found that there were indeed some infirmities. He submitted before this Commission today that he has removed the infirmities to furnish the information to the RTI applicant. He has brought corrected and complete information today which he handed over to the RTI applicant and the same was received by the applicant before the Commission. As such the complaint petition is disposed of.
