The appellant Ms. Rupjan Begum is represented by her husband Md. Mazibor Rahman accompanied by one Atikur Rahman authorised by Ms. Rupjan Begum by her letter dated 25.3.15. The Public Authority is represented by (1) Md. Intazur Rahman, Headmaster, BBSB High School, Barkhetri Barni and (2) Md. Azizar Rahman, Head Master, BBSB ME School, Barkhetri, Barni. The appeal petition dtd 14.11.13 is taken up for hearing in presence of both the parties. The appeal petition has been filed by the petitioner Ms. Rupjan Begum for alleged non-compliance of the commission's order dated 26.7.13. The Head Master of BBSB High School made a written submission dtd 25.3.15 which is entered into the case records.

The Commission's order dtd 26.7.13 had three operative portions (1) imposition of penalty of Rs. 8750.00 (Rupees eight thousand seven hundred fifty) only on the Head Master of BBSB High School. He has since paid the penalty and submitted photocopies of Treasury Challan thereof to the Commission today; (2) The Head Master, BBSB High School to allow the applicant or her authorised representative to inspect the relevant records and give copies thereof free of cost upto maximum 50 (fifty) pages and with cost for additional copies thereafter, and (3) The commission directed to complete the entire exercise within 10 (ten) days.

The appellant's allegation is that the Head Master of the BBSB High School has not complied with the order of the Commission. However, in the written submission dtd 25.3.15 made by the Head Master, BBSB High School stated that after receiving the order of the Commission dtd 8.8.13 he informed the petitioner on 12.8.13 by a letter to collect the required information. On the same day i.e on 12.8.13 the petitioner's husband came to the school at about 2.30 PM without any authorization from the petitioner. The petitioner's husband Md. Mazibor Rahman present today submitted that the Head Master gave some photocopies of documents other than what he wanted. The petitioner's

husband came again next day i.e. on 13.8.13, as submitted by the Head Master in writing today. According to him the petitioner's husband refused to acknowledge the receipt of the documents that the Head Master was willing to hand over, nor did the petitioner's husband give in writing list of specific documents that he wants. On 13.8.13 the petitioner's husband left the School without taking any documents.

The Head Master submitted before the Commission that he is bound to comply with the order of the Commission dtd 26.7.13 provided, the petitioner identifies the documents whose copies she wants. The Commission directs the petitioner or her representative i.e. her husband Md. Mazibar Rahman to specifically mention the list of documents whose photocopies he wants and give it to the Head Master of BBSB High School today before the Commission, who in turn is directed to furnish photocopies against payment of cost if the total pages given exceeds 50 pages. The petitioner's husband prepared a list of documents and handed over the same to the Head master, BBSB High School before the Commission today. The Commission directs the Head Master, BBSB High School to furnish the documents within 15 (fifteen) days from the date of receipt of this order. The petitioner herself will receive the documents or if her husband or any other authorised representative is to receive, then it is to be with due authorization from the petitioner and in either case the documents will be received by giving proper acknowledgement of receipt.

With this order the appeal petition dtd 14.11.13 is disposed of.
