**O R D E R**  
**17-3-2015**

The applicant Sri Moti Ram Nath is present, accompanied by Sri Giasuddin Ali. The Public Authority is represented by Sri R. K. Barua, ADGP (TAP), Assam, Ulubari, Guwahati-7. The case was taken up for hearing in presence of both the parties.

Vide his original RTI application dated 9-9-2014 the applicant wanted to have the photocopies of the answer scripts of dictation and hand-writing examination of all the candidates, whose Roll Nos have been mentioned in the Annexures to the RTI application, and whose examination was held on 15-6-2011. By his second request, the RTI applicant wanted to know the maximum numbers for the examination of hand writing and dictation . He also wanted a Photostat copy of the guidelines for evaluation of the answer scripts.

Vide his query No. 3 the applicant also wanted to have a copy of the order of the Competent Authority with reasons for deferring the date of examination from 25-3-2012 to 15-6-2014.

Finally, by his request No. 5 he wanted a copy of the Govt. order by which the composition of the Selection Board, as Notified vide Advertisement dated 7<sup>th</sup> February, 2012 was changed in 2014.

The representative of the Public Authority submitted that except for giving photo copies of the answer scripts, they have no objection to furnish all the other information as sought for by the RTI

applicant. The Commission directs the SPIO to furnish these information within 15 days from the date of receipt of this order, free of cost, since the SPIO failed to give the information within 30 days.

As regards furnishing photo copies of the answer scripts, the SPIO took the view that they are willing to give the photo copies of the answer scripts to the individual candidates themselves as notified in the advertisement. They have reservations of giving photo copies of the candidates to the RTI applicant, as it may involve third party information. The Commission reserves its decision on this issue.
