The complainant Md.Salim Uddin Talukdar is absent. However, he has informed the Commission's Registry over telephone that he will accept whatever order the Commission passes.

The Public Authority is represented by Sri Madhab Roy, APO(M) and SPIO, DRDA, Cachar. It is seen from a perusal of records that the original RTI petition dated 30<sup>th</sup> April, 2012 was addressed to the Project Director, DRDA, Cachar. The SPIO, DRDA Cachar made a written submission dated 24-4-2015 before the Commission today. In his written submission he has enclosed copies of correspondence between the P&RD Department, Govt. of Assam and DRDA, Cachar. In response to a letter dated 6-7-2012 from Joint Secretary, P&RD enclosing a copy of letter dated 27<sup>th</sup> June, 2012 from Sri Salim Uddin Talukdar, on the same subject as the RTI application, the Project Director, DRDA submitted detailed information to the Joint Secretary, P&RD department regarding consideration of Sri S.U.Talukdar for the post of Computer Asstt. Vide Project Director's letter dated 18-7-2012. It is not known whether the Joint Secretary has communicated the information received from the P.D, DRDA to Sri Salim Uddin Talukdar.

The Commission therefore, directs the SPIO in the office of P.D, DRDA, Cachar to send a copy of his letter No.CRD.129/NREGS/(AE)/10/295 dated 18-7-2012 along with point-wise replies to all the 8 points mentioned in the original RTI application dated 13<sup>th</sup> April, 2012 within 20 days from the date of receipt of this order, which was pronounced before the SPIO.
