## <u>O R D E R</u>

The petitioner Sri Dhanjit Rajbangshi is absent without any information. The public authority is represented by Sri Mukta Nath Saikia, Addl. Deputy Commissioner & SPIO in the office of the Deputy Commissioner, Kamrup (Metro) & Sri Ramenjit Das, Sr. Sub-Registrar of the office of the Deputy Commissioner, Kamrup (Metro).

The second appeal petition dated 9-11-2012 is taken up

for hearing ex-parte.

The ADC and SPIO in the office of Deputy Commissioner, Kamrup (Metro) has made a written submission dated 2-6-2015, which is entered into the case records.

Sr. Sub-Registrar have also made a written submission dated 4-6-2015, which is entered into the case records.

The gist of their submissions is that the petitioner vide his RTI application dated 1-9-2011 wanted to know the present status of a land sale purchase deed between Sri Ramesh Ch. Choudhury and Sri Gopal Rajbangshi along with a copy of the said deed. However, as per submissions of the SPIO & Addl. Deputy Commissioner and Sr. Sub-Registrar the said land sale purchase deed is yet to be completed. Hence, a certified copy of the said deed could not be given to the petitioner. The Sr. Sub-Registrar informed the petitioner accordingly vide his letter dated 30-9-2011, which was produced before the Commission.

However, the Commission is of the view that since the deed has already been executed by the buyer and seller way back in 1992, the petitioner be given a copy of the land sale deed in its present form within 15 days from the date of receipt of this order, informing the petitioner at the same time that the said deed is in an incomplete stage and is yet to be finalized, and report compliance to the Commission within 15 days from the date of receipt of this order.
