ORDER 1762015

The petitioner Shri Sumen Roy is present. The Public authority is represented by Shri Dhrubajyoti Deb, SDO (Sadar) and incharge Circle Officer, Karimgani Revenue Circle accompanied by Shri Satyajit Paul, Head Assistant, Settlement Office, Karimganj. The second appeal petition dtd 2.11.12 is taken up for hearing in presence of both the parties.

From perusal of the case records it appears that the Circle Officer has made a number of correspondences with the petitioner but without giving information sought for by the petitioner with the list of the names of the encroachers on Government land in Kanishail Pt. I & II and Medol Pt. II & III as on 04.2.09.

The Settlement Officer incharge, Karimgani Revenue Circle, Deputy Commissioner & first Appellate Authority, Karimgani and the Circle Officer, Karimganj made written submissions dtd 12.6.15, 15.6.15 and 11.6.15 respectively, which are entered into the case records.

The Circle Officer, Karimgani Revenue Circle submitted that after completion of the settlement operation the maps have been sent to the Joint Director, Survey, Assam for printing of new maps after the same have been approved by the Settlement Officer. He therefore, has difficulty in giving a list of encroachers as sought for by the petitioner with reference to the duly approved and printed maps. After hearing the Circle Officer and the petitioner, the Commission directs the Circle Officer, Karimgani Revenue Circle to give the list of encroachers only to the petitioner as sought for by him on the basis of draft settlement records or information available with the RKG Branch.

The Circle Officer prayed for 30 day's time from today to furnish the information as directed by the Commission or revert back to the Commission, if he has any difficulty in furnishing the information.
