**O R D E R**  
18.5.2015

The petitioner is absent without any information or seeking leave of the Commission. The Public Authority is represented by Shri Rupak Bhattacharjee of Assam Plantation Crops Dev. Corporation Ltd. The petition dtd 13.1.14 submitted by the petitioner for compensation of Rs. 10,000.00 ( ten thousand) is taken up for hearing ex-parte.

The Commission perused earlier orders dtd. 27.9.11 and dtd 14.2.12 of this Commission. The Commission also perused the written submission dtd 15.5.15 made by the SPIO of APCDCLtd with enclosures which is entered into the case records. It is seen that the SPIO of APCDC Ltd had informed the Deputy Commissioner, Kamrup (M) vide letter dtd 29.9.10 that till date there was no gradation list of employees of APCDC Ltd and that the selection meeting held on 13.8.10 for promotion ended without taking any decision and preparing a select list. Since there was no gradation list and selection list, the Corporation could not furnish the same to the petitioner. However, from the records it is not clear whether a copy of the said letter was furnished to the petitioner as directed by the Commission vide its order dtd 14.2.12. The Commission directs the Chairman, APCDC Ltd and the SPIO, APCDC Ltd to send a copy of the said letter to the petitioner by registered A/D post within 7 (seven) days from the date of receipt of this order.

In view of the Commission's earlier order dtd 14.2.12 and the facts and circumstances of the case, the Commission rejects the prayer of the petitioner for compensation.
