The petitioner Shri Jayanta Das has authorised Shri Gopal Chandra Bora and Shri Bidhan Ranjan Das to represent him in today's hearing. Both Shri Gopal Ch. Bora and Shri Bidhan Rn. Das are present. The Public Authority is absent without any information or seeking leave of absence from the Commission. The second appeal petition dtd 19.11.14 is taken up for hearing ex-parte.

Vide letter dtd 30<sup>th</sup> June, 2014 the Deputy Secretary, Govt. of Assam , Education ( Secondary) Department responded to the RTI petition dtd 6.6.14. The representatives of the petitioner submitted that they are not satisfied with the information furnished by the Deputy Secretary to the Govt. of Assam vide their letter dtd 30<sup>th</sup> June, 2014. On point No. 1 (one), the representatives of the petitioner submitted that they will be satisfied if they receive the information on vacancy position of Assistant Teachers in different High Schools and Higher Secondary Schools of Nagaon district as on 6.6.2014.

The Commission directs the Commissioner & Secretary, Govt. of Assam, Education ( Secondary) Department to furnish this information, to the petitioner in whichever form or stage it is available, within 15 ( fifteen) days from the date of receipt of this order.

On point No. 2, 3 & 4, the commission has perused the information given by the Deputy Secretary, Govt. of Assam vide their letter dtd 30<sup>th</sup> June, 2014. The Commission directs the Deputy Secretary to the Govt. of Assam, Education (Secondary) Department to furnish the latest information to the petitioner regarding point No. 2, 3 & 4 within 15 ( fifteen) days from the date of receipt of this order.
