The appellant Md. Sahir Ali is present. The Public Authority is represented by (i) Sri Mushahak Ali, District Project Engineer, SSA, (ii) Md. Mahbul Rahman Khalifa, Asstt. Teacher, Bhedamari L.P. School and (iii) Sri Nupur Nath, Work site Technical Person, Sipajhar. The First Appellate Authority, i.e., the District Mission Coordinator who is also Addl. Deputy Commissioner (Development), Darrang district is absent. But he has authorized the District Project Engineer to appear before the Commission today vide his letter dated 27-2-2015.

It is seen from the case record that the RTI petition relates to construction of the new building in Sialmari Gaon L.P. School. The concerned Public Authority for this purpose is the District Mission Coordinator. The information sought for by the applicant are (1) estimated cost of construction of the new school building, (2) copy of the estimates, (3) copies of the Measurement Books, (4) Copies of the Pass Book and (5) amount of interest accrued against the deposits of the school Bank account. Md. M. R. Khalifa, Asstt. Teacher and ex-Member Secretary of Bhedamari L. P. School submitted that he will be able to furnish the required information relating to (a) the estimated cost of the construction of the new building, (b) copies of the estimates, (c) copies of the Measurement Books and (d) Copies of the Pass Books from 1.1.2013 till 31.12.2014. Interest accrued on the accounts during the said period will be available in the Pass Book.

Md. Khalifa further stated that he has brought all the relevant information with him. In view of the above, the Commission directs the Assistant Teacher and ex-Member Secretary of the Bhedamari School Management Committee Md. Kalifa to hand over the relevant documents to the applicant, which he did before the Commission today and the same was received with acknowledgement by the RTI applicant.

In view of the above, the Second Appeal petition is disposed of and the matter is closed.
