Sri Salim Ahmed, appellant and Dr. A. Gogoi, SPIO Elementary Education and Joint Director, Elementary Education are present. Heard both the parties. On behalf of the SPIO, Director, Elementary Education Dr. A. Gogoi submitted that as per their office records, **the original RTI application dated 12th September, 2012 submitted by the appellant Sri S. Ahmed could not be traced.** They have collected a copy of the RTI application from ASIC office, only yesterday. Whether any action was taken on the prayer petition dated 30-1-2012 of Abul Hussain , Head Master, Gunaipani M.E. Madrasa will depend on whether that application was at all received by the Director of Elementary Education. The submission made by SPIO in writing was noted.

The appellant did not come prepared with any supporting evidence of receipt of Shri Abul Hussain's prayer petition by the office of Director, Elementary Education.

After hearing both the parties, **15 days time is granted to the SPIO to search and trace out the prayer petition of Shri A. Hussain and Action Taken Report thereon, if any.** Same time is also granted to the appellant to come with any supporting evidence that he may gather to substantiate receipt of Sri Abul Hussain's petition in the office of the Director of Elementary Education.

Next date of hearing may be fixed on 4th February, 2015 at 11.30 A.M
