The petitioner Shri Gitaritha Kr. Das is absent without information. The Public Authority is represented by Dr. Sujit Bordhan, Dy. Registrar and SPIO, Srimanta Sankaradeva University of Health Sciences, Guwahati-32. The second appeal petition dtd. 27.7.12 is taken up for hearing ex-parte.

It is seen from the case records that the RTI petition dtd 8.2.12 submitted by Shri Gitaritha Kr. Das, the petitioner, was addressed to the SPIO of FAA Medical College & Hospital, Barpeta. The Medical College transferred the RTI petition to SSUHS on the same day i.e. 8.2.12. The SPIO of FAA Medical College & Hospital's written submission dtd 23.6.15 is entered into the case records.

The SPIO and Dy. Registrar of SSUHS Dr. Sujit Bordhan has made a written submission dtd 18.6.15, which is entered into the case records. He enclosed their communication dtd 13.3.12 addressed to the petitioner. Vide this communication the petitioner was advised, inter alia, to deposit Rs. 48.00 to obtain photocopy of the answer script of the petitioner, who appeared in the written test for the Gr. IV post under the establishment of FAA Medical College and Hospital, Barpeta. The SPIO has stated in his written submission that the petitioner has not deposited the requisite fees till date.

In view of the above and in absence of the petitioner, the second appeal petition dtd 27.7.12 is disposed of.
