The petitioners/appellants as well as the Public Authority – both are absent. From the case records it is seen that as the first Appellate Authority, the Asstt. Director, FCS&CA, Udalguri, BTAD passed an order on 28.5.12 wherein he has stated that the incharge Superintendent, FCS&CA, Bhergaon was a new incumbent at that time and submitted that he shall provide the required information to the petitioner by 8.6.12. Both the parties agreed to this. Now, the petitioners have filed a second appeal petition dtd 27.8.12. The appellants have listed 12 grounds on which they have filed the second appeal petition. It can, therefore, be presumed that following the order of the first Appellate Authority, the appellants Shri Mukesh Boro and Bhabesh Saharia received some information from the concerned Superintendent, FCS&CA. But the appellants have not enclosed a copy of the information furnished to them which according to them are incomplete. In the absence of a copy of information received by them from the Public Authority, and in the absence of both the parties without information, the Commission is not in a position to assess the merit of the second appeal petition. Hence the second appeal petition is disposed of.
