## <u>O R D E R</u> 07.7.2015

The petitioner Md. Suhail Ahmemd Choudhury is absent without any information The Public Authority is represented by Shri Khagen Deka, Statistical Assistant of the office of the Directorate of Elementary Education, Assam. The second appeal petition dtd. 27.5.14 is taken up for hearing exparte of the appellant.

The Jt. Director and SPIO of the office of the Directorate of elementary Education, Assam has made two separate written submissions dtd. 2.7.15 & 3.7.15 which are entered into the case records. The Director, Elementary Education has also made a separate written submission dtd 5.7.15, which is also entered into the case records.

The Director in his written submission stated that the RTI petition was transferred by his office to the Jt. Director, Elementary Education, Dr. Lok Nath Sarma. It is seen that vide letter dtd 30.6.15 the SPIO and Jt. Director, Elementary Education, Assam has furnished the required information to the petitioner in response to his RTI application dtd 20.1.14. In absence of the petitioner it could not be ascertained whether he has received the information sought for by him.

In view of the written submission of the SPIO and the Jt. Director that he has furnished the information to the petitioner, the Commission accepts his

submission with further direction that if the petitioner claims not to have received the information then he can approach the office of the Jt. Director, Elementary Education, Assam, Kahilipara, Guwahati-18 within 30 days from the date of receipt of this order and the SPIO will furnish the information.

In view of the above order the second appeal petition dtd 27.5.14 is disposed of.
