The petitioner/complainant as well as the Public Authority – both are absent. However, from perusal of the case records it is seen that the complaint petition dtd 8.10.12 has been filed by an Advocate Md Taz Uddin Laskar on behalf of his two clients namely (1) Md. Abdul Jalil Mazumder and (2) Md. Sarif Uddin Sodial. Prior to that he filed an appeal petition before the Commission on 30.3.12 followed by a reminder on 20.6.12. The first appeal petition dtd 30.3.12 of Md. Taz Uddin Laskar was forwarded by this Commission to the first Appellate Authority i.e. District Elementary Education Officer, Cachar, Assam on 7.7.12. In absence of both the parties it could not be ascertained whether the first appeal petition was heard and disposed of by the first Appellate Authority or whether the concerned SPIO has furnished the information to the RTI applicants or to the appellant.

In view of the above, the Commission directs the District Elementary Education Officer, Cachar to dispose of the first appeal petition by giving hearing to both the petitioners, the appellant, the concerned BEEO and Head Teacher of South Masimpur L.P. School within 30 days from the date of receipt of this order. In disposing of the appeal petition, the first Appellate Authority will also take note of the communication from the concerned Head Mistress of the Masimpur L.P. School to the RTI applicants vide her letter dtd 23.12.12 asking the applicants to deposit the cost of photocopy charge.

With the above order, the complaint petition dtd 8.10.12 is disposed of.
