**O R D E R**  
20.7.2015

The appellant Sri Soumitra Sengupta is absent without any information. The public authority is represented by Sri Sanjib Kr. Das, Joint Secretary and SPIO, Revenue and Disaster Management Department and Dr Nabajit Saikia, Assistant Professor, ETE Department, Assam Engineering College, Jalukbari, Guwahati.

The second appeal petition dated 7-1-2015 was not heard on 8-6-2015 although both the parties were present. On that date the Commission observed that the same petitioner had filed 2 other appeal petitions on the same subject which were registered as Case Nos. SIC/KP(M).58/2013 and SIC/KP(M) 162/2013. These two cases were clubbed together and the Commission passed a speaking order on 7-1-2015. The Commission, therefore, fixed 20-7-2015 for hearing of the present appeal case after going through the contents of the other two appeal cases mentioned above.

As already mentioned, the petitioner was absent without any information. The SPIO and Joint Secretary to the Government of Assam, Revenue and Disaster Management Department made a written submission dated 20-7-2015. The Asstt. Professor ETE of Assam Engineering College, Jalukbari also made a written submission dated 16-7-2015. Both the written submissions are entered into the case records. However in the absence of the petitioner the Commission decided to give the petitioner one more opportunity of being heard before passing any final order on the second appeal petition dated 7-1-2015. Fix **20-8-2015** for next hearing at 11 A.M.
