**O R D E R**

13.7.2015

The petitioner/ complainant Md. Hanif Ali is absent without any information. The Public Authority is represented by Shri Chabi Ranjan Das, Sr. Assistant in the office of the Asstt. Registrar, Co-operative Societies Barpeta and Md. Shahadat Khan, Secretary, Pachim Sarukhetri GPSS Ltd.

The Dy Registrar of Co-operative Societies and incharge Asstt. Registrar, Co-operative Societies, Barpeta has sent a written submission dtd 10.7.15. It is seen from the enclosure of the written submission that as first Appellate Authority, the Asstt. Registrar, Co-operative Societies heard the petitioner Md. Hanif Ali and the Secretary Pachim Sarukhetri SS Ltd Md. Shahadat Khan. It is also seen that the Secretary PSGPSS kept the information ready for collection by the petitioner, but he refused to collect it. The first Appellate Authority also directed the Secretary of the GPSS to provide the required information in respect of the Fair Price Shop of Smt. Monowara Begum to the petitioner Md. Hanif Ali. Again the petitioner did not turn up to collect the required information from the GPSS's office. The Secretary of the GPSS submitted that it is not possible to send the information sought for as it is very voluminous covering the period from 2006 to 2011, which will run into more than 2000 pages.

Since the information is ready with the Secretary, Pachim Sarukhetri SS Ltd, the Commission therefore, directs the Secretary of the GPSS to allow the

petitioner Md. Hanif Ali to inspect the documents during office hours on any working day within 15 days from the date of receipt of this order and take notes of the documents as may be necessary to the petitioner. The Commission also directs the Secretary, GPSS to provide photocopies of documents sought for by the petitioner free of cost up to 50 copies and thereafter on payment of Rs. 2.00 for every additional copy.

With the above order, the second appeal petition dtd 2.3.13 is disposed of.
