**O R D E R**

13.7.2015

The petitioner Shri Satyaranjan Saikia is absent without information. The Public Authority is represented by Shri Mahendra Nath Baruah, DCF and SPIO in the office of the Conservator of Forests, Eastern Assam Circle, Jorhat. The second appeal petition dtd 17.8.12 is taken up for hearing ex-parte.

From perusal of the case records it is seen that the Working Plan Officer of the Upper Assam Circle under Conservator of Forests had already furnished some information to the petitioner on 10.7.12 followed by letter dtd 6.7.12 to the petitioner from the SPIO and the Dy. Conservator of Forests and again by letter dtd 7.8.12 by the First Appellate Authority i.e. Conservator of Forests, Eastern Assam Circle, Jorhat.

Not satisfied with the information already received, the petitioner filed second appeal petition dtd 17.8.12 before this Commission. Shri Mahendra Nath Baruah SPIO in the office of the Conservator of Forests, Eastern Assam Circle submitted that he had brought with him additional information in response to the RTI application of Shri Satyaranjan Saikia. In absence of the petitioner Shri Satyaranjan Saikia it could not be ascertained whether additional information brought by the SPIO will satisfy him. In the absence of the petitioner/appellant, the Commission could not proceed further but directed the SPIO to send the additional information to the petitioner by registered A/D post within seven days from the date of this order with intimation to the Commission.

In view of the above order the second appeal petition dtd 17.8.12 is disposed of.
